### Spring Lake Heights Police Department NARRATIVE FOR PATROLMAN CHRISTOPHER BENNETT

Ref: 07SLH-45-AR

On the above date and time Ptl. Gunnell and myself where dispatched to 2407 Hwy 71 for a car owner reporting someone hit a tree with his vehicle and left the scene south on Hwy 71 on foot, Ptl. Gunnell and myself arrived on scene and I observed a white male with brown hair standing next to a Nissan pickup color black. The truck was covered in mud and had severe front end damage. Ptl. Gunnell and myself began speaking with the white male. He advised us that he allowed his friend to drive his truck. The friend then hit a tree with his truck and got it stuck in the mud. After they removed the truck from the mud, his friend then drove the truck to 2407 Hwy 71 where he parked it. The friend then exited the truck and began walking south on Hwy 71 leaving him alone with a severely damaged vehicle. As Ptl. Gunnell and myself spoke with the subject we could smell a strong odor of alcoholic beverage coming from his mouth and person. The subject's speech was slow and slurred as he told us his story. His eyes were blood shot and watery. When he gave Ptl. Gunnell his drivers license his hands were slow and fumbling. As Ptl. Gunnell spoke with Warren Chabot, I observed another white male sitting on the curb in front of Naples Pizza across from where the truck was parked. I walked over to the subject and asked the male if he observed the Nissan pickup pull up and if so who was in the vehicle. The subject stated that the white male Ptl. Gunnell was talking to was driving the truck and that he was in the passenger seat. I asked him again who was in the Nissan pickup and he advised me that he was in the passenger seat and his friend Warren Chabot was driving. I asked him for his ID. He complied by giving me his NJ drivers license (William Rutkaitis 01/17/87). At this time, I advised Ptl. Gunnell of William's story. Ptl. Gunnell placed Mr. Chabot into his patrol vehicle to transport him back to police headquarters for further questioning. I asked Ptl. Blecki from Spring Lake Police Department to transport William back to police headquarters for further questioning and I began searching in the area where William stated the accident took place. At the intersection of Meadow St. and 5th Ave. in Wall Township I observed two trees with branches broken and fresh bark missing from them. I also observed two large tire tracks in the mud starting from the edge of the roadway and continuing up to the two damaged trees. Wall Township Police Department was contacted and advised of the incident and location of the accident. At police headquarters, William was placed in the report room and advised of his miranda warning. He verbally stated that he understood. William then gave me a written statement of what happened. William stated that Warren and himself were at Sea Girt Bowling Lanes Rt. 35 in Wall Township drinking beers and bowling. They left the bowling alley and Warren began driving unfamilar residential streets in Wall Township. He then stated that the truck ran off the roadway, hit a tree, and got stuck in the mud. After Warren got the truck out of the mud, William told Warren to let him drive. Warren let William drive to the nearest parking lot and parked his truck. William then went and got some food as Warren called the police. As I spoke with William I could smell a strong odor of alcoholic beverage coming from his breath and person. His eyes were blood shot and watery. As I advised Ptl. Gunnell of William's statement he advised me that Warren continued to tell him he did not remember what happened. I then went into the court room where Warren was sitting and asked him what happened with his truck. He continued to tell me that he did not remember. I then advised him that William gave me a verbal and written statement of what happened and William's statement was different from his. Warren began to tell me what had happened. His story was the same as Williams. Warren also advised me that he was sorry for lying. The reason why he lied was because they both were drinking and driving and did not want to get into trouble with the police. I then asked Warren to perform some field sobriety tests and he complied. Test #1. I asked Warren to do the alphabet test. He recited the alphabet from A to Z. While he was recited the letters his speech was slow and slurred. He was swaying from the left to the right and he placed his hands away from his body for balance.

Test#2. I asked Warren to do the heel to toe test. He walked eight steps forward and ten steps back (not as instructed). He did not count the steps out loud. He staggered when he did the turn around and he placed his hands away from his body for balance.

Test#3. I asked Warren to do the one legged stand test. He placed he right heel on the ground only lifting the front of his foot off the ground and began counting. He counted to 15 before I advised him to stop. When he

counted his speech was slow and slurred. He continued to sway back and forth. Again, he placed his hands away from his body for balance.

At this time, I advised Warren he was under arrest. I read him the breathalyzer consent form and he responded "sure" to the taking of breath samples. As I began the purging of the breathalyzer, there was a problem with the machine. I stopped the testing procedure. I placed Warren in handcuffs and into the rear of my patrol vehicle. I transported him to Sea Girt Police Department to use their breathalyzer. I put Warren through the breathalyzer procedures. His readings were .13% and .13%. I then relinquished Warren to Ptl. Gunnell and I placed William through the breathalyzer procedures. His readings were .11% and .11%. I then transported William back to Spring Lake Heights Police Department.

At headquarters, I issued Warren two motor vehicle summons and one Municipal Complaint. I advised him of his court dates and released him to his girlfriend, Crystal Bailey, after she signed the potential liability warning.
