

**ORDINANCE OF THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF TOMS RIVER, OCEAN COUNTY, NEW JERSEY, AMENDING AND SUPPLEMENTING SECTION 477-79, SCHEDULE XXI (SPEED LIMITS) OF CHAPTER 477 (VEHICLES AND TRAFFIC) OF THE TOWNSHIP CODE, REDUCING THE SPEED LIMITS ON:**

**GARFIELD AVENUE – REMOVING ZONES 1, 2, 3 AND 4, AND GARFIELD AVENUE BETWEEN RIVERSIDE DRIVE AND ROUTE 37, AND GARFIELD AVENUE BETWEEN ROUTE 37 AND COTTONWOOD DRIVE, AND ESTABLISHING NEW ZONES 1, 2 AND 3, IN ORDER TO PROMOTE ENHANCED VEHICULAR AND PEDESTRIAN SAFETY**

**BE IT ORDAINED** by the Township Council of the Township of Toms River, Ocean County, New Jersey as follows:

1. Section 477-79, Schedule XXI (Speed Limits) of Chapter 477 (Vehicles and Traffic) is hereby amended and supplemented to delete the speed limits on Garfield Avenue, as follows:

<u>Garfield Avenue</u>	<u>Speed (mph)</u>	<u>Location</u>
Zone 1	30	From Riverside Drive to Route 37
Zone 2	35	Route 37 thence to Windsor Avenue
Zone 3	40	Windsor Avenue thence to Delaware Avenue
Zone 4	35	Delaware Avenue thence to Cottonwood Drive
Garfield Avenue	30	Between Riverside Drive and Route 37
Garfield Avenue	35	Between Route 37 and Cottonwood Drive

2. Section 477-79, Schedule XXI (Speed Limits) of Chapter 477 (Vehicles and Traffic) is hereby amended and supplemented to establish reduced speed limits on Garfield Avenue to promote enhanced vehicular and pedestrian safety, as follows:

<u>Garfield Avenue</u>	<u>Municipal Speed Limit</u>	<u>Location</u>
Zone 1	25	From Riverside Drive to Route 37
Zone 2	30	From Route 37 to Windsor Avenue
Zone 3	25	From Windsor Avenue to Cottonwood Drive

3. All ordinances or parts of ordinances which are inconsistent herewith are repealed, but only to the extent of such inconsistency. All other parts of Chapter

477 of the Code of the Township of Toms River not inconsistent herewith are ratified and confirmed.

4. If any part or parts of this Ordinance are for any reason held to be invalid, such adjudication shall not affect the validity of the remaining portions of this Ordinance.

5. This ordinance shall take effect following its final passage by the Township Council, approval by the Mayor, and twenty days after publication as required by law and the posting of the appropriate signs.
