Mr. Salonis,

I am writing to follow up on our phone conversation from February 20, 2025, and to confirm your instruction regarding Police Officer candidates Theodore Golubowski and Nicholas Sura (Candidates #1 and #3 from the attached hiring list). As per your direction, these candidates will not be hired and will not be sent to the Ocean County Police Academy for the Basic Course for Police Officer training.

To recap, both candidates were approved for hire by you and Mayor Rodrick via the DMS Workflow PRAC form on January 2, 2025. Following this approval, the candidates underwent the standard medical exam, psychological evaluation, stress test, and drug screening/toxicology. They both passed these assessments and remained in good standing for hire. Additionally, their Police Academy uniforms were ordered, and each candidate received a Conditional Offer of Employment with plans for them to be hired prior to the Police Academy's start date of March 14, 2025.

Unless I receive further instruction, I will proceed with rescinding the Conditional Offer of Employment extended to both candidates. Please let me know if you require any further information or clarification.
